The technical bids will be opened on **01.09.2021** at **11.00 hours** in the office of the undersigned. The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside Odisha state can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the state government within a month of acceptance of bid.

2. **The amount put to tender is exclusive of 12% GST. The intending bidder should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on Works Contract shall be paid over the bill amount at the time of payment of bill.**

4. Cost of Bid Document will be paid on online mode for each Bid respectively as mentioned in Column.4.
5. The Bidders shall execute a **"Bid Security Declaration"** in lieu of bid security with stipulation that if they withdraw or modify their bid during period of validity etc., they will be suspended for the time specified in the tender document. Bid security declaration to be furnished in the prescribed form in the DTCN.


6. The **Bid documents will be available** in the website: www.tendersorissa.gov.in from **10.00 A.M of 13.08.2021 to 5.30 P.M of 27.08.2021 for online bidding.**
7. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
8. Bids shall be received only **"online" on or before 5.30 P.M of 27.08.2021.**
9. Bids received on line shall be opened at **11.00 A.M. on 01.09.2021** in the office of the **Executive Officer, Kuchinda NAC, Kuchinda** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
10. After the date & time of receipt of bid is over, the copy of Bid documents shall be submitted in the office of the undersigned on or before date & time of opening of Bid as specified at Para 08 above, during office hours on working days failing which the bid will be rejected.
11. **The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy of affidavit to the effect that the he has not yet availed the facility /participated in the tender for more than two works (Excluding this work) during the current financial year.** The name of work which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original affidavit, original engineering license certificate in the office of the undersigned on or before date & time of opening of bid as specified Para-8 above during office hour on working days for recording necessary entry for exemption of EMD failing which the bid shall be rejected.
12. The original documents of scan copies furnished in e-tendering process by the bidder shall be submitted within 3 (three) days of opening of the tender for verification so-motto failing which the tender will be considered as Non responsive.
13. Other details can be seen in the bidding documents.
14. If the % rate quoted by any bidder for any of the above mentioned work is lower than or equal to 15% less(-), then such bid shall be rejected and the tender shall be finalized based on merits of the rest bids. But, if more than one bid is quoted at 14.99% (decimals up to two numbers will be taken for all practical purposes) less, the tender shall be finalized through a transparent lottery system, where all such bidders/their authorised representatives will remain present.
15. **Amendment to Para-3.5.5 (V) of OPWD Code, Vol-I by modification Note-(I) – "Additional Performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rate than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional performance security (APS) in shape of Demand draft / Term deposit Receipt pledged in favour of Executive Officer, Kuchinda N.A.C., Kuchinda by the L-1 (first Lowest) tenderer within 07 (seven) days of receipt of intimation from the office ,otherwise the bid shall be cancelled and the security deposit shall be forfeited . Further proceeding for blacklisting shall be initiated against bidder". Failing which the bid of the L-1 tenderer will be treated as disqualified and the next eligible bidder will be called for.**

Insertion of another ground for blacklisting of contractor-“Non submission of Additional Performance Security (APS) within stipulated period in pursuance to Works Department Office Memorandum No. 14299/W dt.03.10.2017” as Sub-Rule-“g” under Rule-A of Appendix –XXXIV of OPWD Code Vol-II.

16. The bid shall remain valid for a period of 90 days from the date of opening of Price Bid. Subsequent extension of validity of tender of the L1 eligible bidder shall be subject to mutual consent of the respective bidder and Executive NAC, Kuchinda
17. If any site problem arises regarding land acquisition during layout, the authority will not be responsible.
18. This notice is to be read with all the Clauses / addendum to the “Procedure to participate in online bidding”. Any corrigendum /Addendum will be displayed in the website www.tendersodisha.gov.in only.
19. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
20. Any tenderer desires to avail any facility as per certain circular /order of Govt. have to apply for same along with tender paper. Claim at the time of opening of tender or later will not be entertained.
21. Authority will not be held responsible for any technical problem/ failure of network, server during the schedule dates of online bidding.
