If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 10. After the date & time of receipt of bid is over, the copy of Bid documents shall be submitted in the office of the undersigned on or before date & time of opening of Bid as specified at Para 08 above, during office hours on working days failing which the bid will be rejected.
- 11. The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy of affidavit to the effect that the he has not yet availed the facility /participated in the tender for more than two works (Excluding this

work) during the current financial year. The name of work which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected.
