

9. Bids shall be received only "online" on or before 5.30 P.M of Dt. 27.12.2021.

- 10. Bids received on line shall be opened at **11.00 A.M. on Dt. 28.12.2021** in the office of the **Executive Officer, Kuchinda NAC, Kuchinda** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 11. After the date & time of receipt of bid is over, the copy of Bid documents shall be submitted in the office of the undersigned on or before date & time of opening of Bid as specified at Para 08 above, during office hours on working days failing which the bid will be rejected.
- 12. The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy of affidavit to the effect that the he has not yet availed the facility /participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original affidavit, original engineering license certificate in the office of the undersigned on or before date & time of opening of bid as specified Para-8 above during office hour on working days for recording necessary entry for exemption of EMD failing which the bid shall be rejected.
- 13. The original documents of scan copies furnished in e-tendering process by the bidder shall be submitted within 3 (three) days of opening of the tender for verification so-motto failing which the tender will be considered as Non responsive.

If the % rate quoted by any bidder for any of the above mentioned work is lower than or equal to 15% less(-), then such bid shall be rejected and the tender shall be finalized based on merits of the rest bids. But, if more than one bid is quoted at 14.99% (decimals up to two numbers will be taken for all practical purposes) less, the tender shall be finalized through a transparent lottery system, where all such bidders/their authorised representatives will remain present.

# **INSTRUCTION TO TENDERERS:**

- 1. Tenderers should be registered as contractor of appropriate class P.W.D. /R.D. / Water Resources/P.H.D of Government of Orissa/ Kuchinda NAC/Central Government/MES/Railways.
- 2. Only those tenderers who are willing to accept all the terms & condition of his detailed tender call notice need submit the tenders.
- 3. Upon acceptance of tender the successful tenderer or shall within a period of ten days from the date of written information of acceptance of the tender deposit a sum of such amount towards initial security as would together with the earnest money make two percent of the cost of the work as per the accepted tender and sign item rate agreement in the contract form of Kuchinda NAC in the office of the Kuchinda NAC. Failure to deposit his additional amount towards initial security deposit or to sign the contract within the stipulated time will make the earnest money deposit of the tendered liable to forfeiture and acceptance of this tender shall be treated as with-drawn.
- 4. The written item rate of agreement of Kuchinda NAC to be entered into between successful tendered herein after called the contractor and the Kuchinda NAC shall be foundation of the rights of both the parties and the contract shall be deemed to be incomplete until the agreement has been first signed by the contractor and then by the proper officer authorized to enter in to the contract on behalf of the Kuchinda NAC.
- 5. The acceptance of the tender and award of the contract to more than one contractor if considered necessary will rest with the Executive Officer, Kuchinda NAC who does not bind himself to accept the lowest tender and will reserve to himself the authority to reject any or all of the renderers received without assigning any reason thereof.
- 6. The earnest money deposit of the tenders who are not awarded with the work will be refunded on receipt of written request.
- Submission of scanned copies of certificate/documents.
  The Bidder has to submit scanned copies of the following certificate and documents.

- 8. Canvassing in any form is prohibited & the tender submitted by the tenderers who resort to canvassing will be rejected and the tenderer will not be allowed to tender for any other works in Kuchinda NAC.
- 9. Details of drawing & specification as are not supplied with the tender documents for the work may be seen in the office of the Kuchinda NAC on working days during office hours.
- 10. The detailed specification for all items of work involved in the work shall be in accordance, with ISS/State PWD/Public Health Department specification of Government of Orissa. In case of variations in the provision of the code of

specifications of work referred to above the decision of S.E.P.H., Circle, Bhubaneswar as regards the specifications to be adopted in the work shall be final, conclusive & binding on both the parties. Every tenderer must examine the aforesaid specifications before submitting his tender. The Executive Officer or his authorized subordinate reserve the right, without imparting the contract, to make such increase or decrease in the quantities or items of works mentioned in the scheduled attached to be tender notice as may be considered necessary to complete the work duly and satisfactorily. Such increase or decrease will in no case invalidate the contract rates. It should be understood that the quantities are tentative and may vary according to site conditions. #### OFFICE MEMORANDUM

#### Subject: Bid Security / Earnest Money Deposit (EMD)

To safeguard agains: a bidder's withdrawing or altering its bid during the bid validity period, Bid Security (also known as Earnest Money Deposit) is obtained from bidders except those who are exempted from paying Bid Security as per para-21 of FDOM No 4939/F Dated 13.02.2012. Besides, the State Government have exempted Micro and Small Enterprises (MSEs) as defined in Odisha MSME Development Policy, 2016 and Start-ups as defined under Odisha Start-ups Policy, 2016 from payment of Bid Security while participating in tenders vide FDOM No 27528/F Dated 16.10.2020.

2. The State Government is in receipt of many representations that on account of slowdown in economy due to the pandemic, there is acute financial crunch among vendors, which in turn is affecting timely execution of the contracts. It has also been represented that this may affect the ability of vendors to bid in tenders and hence reduce competition. Besides, Government of Incia have made provision in Rule-171 of General Financial Rule, 2017 asking the bidders for executing a "Bid Security Declaration" in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents.

3. Considering the difficulties faced by the vendors and to facilitate competition in wake of slowdown of the economy due to Covid-19 pandemic, it is hereby decided that no provisions regarding Bid Security should be kept in the Bid Documents and only provision

for "Bid Security Declaration" should be kept. Further, wherever, there are compelling circumstances to ask for Bid Security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender.

 These instructions shall be applicable for all kinds of procurements viz Goods, Consultancy, Non-consultation and Works.

 These instructions shall be deemed to be a part of Odisha General Financia Rules.

Works Department shall make suitable amendment in the relevant provisions of OPWD Code.

The above instructions will be applicable for all the tenders issued till 31.12.2021.
