

Kuchinda NAC: Kuchinda is a Sub-Divisional headquarter town about 85 Kms from Sambalpur and is at a distance of 290 Kms from the capital city of Bhubaneswar. This town is having a link with National Highway 49 (Chandikhol –Raipur) to Deogarh. The Nearest Railway station is Jharsuguda (45 Km) and Bamra (47Km). Kuchinda is located at 21.73°N 84.35°E. It has an average elevation of 220 meters (721 feet).

Bidder Eligibility: The Bidder / Agency / Farm should have been registered under Indian

Companies Act or similar and should have experience of similar consultancy services in survey / DPR preparation etc. in last 3 years.

Experience:

The consultant should have adequate survey experience including that of topo survey, drone survey. The consultant should have previous experience and must have undertaken similar nature of work under any Development authority / Urban Local Bodies of the State or any Department of State Government and Central Government or any corporate body.

- b) Successful bidder should submit the details of longitude, latitude, under water level, etc. as required by H&UD Department, along with the 3D map of the existing dumpsites.
- c) Selected bidder will bear all the cost as per the scope of work including submission of all the documents and report as per requirement.
- d) In case more than one bidder quoted with same lowest price for same item, then the tender accepting authority will finalize the tender through a transparent lottery system in presence of authorized representatives of the bidder.
- e) Selected bidder will complete the assignment within stipulated time frame from the date of issue of work order.
- f) In case the service delivered is not satisfactory, penalty, as per statute / govt. order shall be levied and shall be deducted from the bill amount.
- g) Weightage will be given to the bidder who has similar type of experience.
- h) Payment will be made to the successful bidder after submission of all the documents as per requirement in both hard and soft copy along with bill as per certification of concerned Nodal Officer/ Engineer-In-Charge.
