1. The vehicle must be in Road worthy condition shall not be more than 1 years old from the date of initial registration and must have valid registration Certificate, GST Registration Certificate, Insurance Certificate, Fitness Certificate, proof of up to date tax payment, Valid Contract Permit, Valid PUC Certificate etc. which are mandatory for running of the vehicles.
2. The Driver of the vehicle must have a valid Driving License for driving of tractors/LCV and should be sufficiently experienced in driving of the tractors/LCV.

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing of vehicles (hydraulic tractors with Trolleys/LCV) on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV document such as: - valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid permit, proof up to date tax payment, PUC Certificate etc. and requisite D.L. of driver available all the times. Kuchinda NAC hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or losses of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis in final but does not include cost of Diesel/Petrol. The required Diesel/Petrol will be provided by Kuchinda NAC as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts; Lubricating oil of Engine, gear Box & differential Coolant, Tyres & Tubes Battery etc. will be borne by The bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by owner/bidder.
4. In case of the breakdown for reasons whatsoever the replacement of a vehicle of the same of better or same model shall be provided by the owner of the vehicle/bidder.

5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicles from other source.
6. The vehicle should report for duty for all the days in a month.
7. In case of emergency / special occasion, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges for a period of contract of 2 (two) Years to the selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 1 year old and also in good running condition during the period of contract.
10. If the service is found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the Terms of Contract, Kuchinda NAC shall forfeit the entire amount of security deposit.

Provision of vehicles by bidder:

The bidder shall provide the required vehicles (as mentioned in the Work Order) in the period of the contract period. At the end of 2 years, the contract may be extended for further period at the sole discretion of Kuchinda NAC subject to satisfactory performance, requirement of the office & mutual consent of both the parties. The maintenance and upkeep of the vehicles shall be the responsibility of the operator.

Specification of Vehicles

The vehicle shall be well manoeuvrable, diesel/petrol fuel, equipped with hopper (auto tipper) of capacity covering 500 to 700 kg, For example, Tata Ace, Mahindra, Ashok Leyland or any other similar vehicle.

The vehicles should be branded LCV like TATA, Mahindra, Ashok Leyland etc.

Engine type should be BS-VI (brand new vehicle)/BS-VI/BS-VI2.0 minimum two cylinder minimum 800 cc with 7.Shp@ 3600 rpm & wheel base of 2100 MM.

The vehicle shall have twin bin closed container having partition with lead cover.

Painting Inside and outside of the vehicle will be painted with enamel paint.

The Vehicles shall meet with speed governor as per the existing RTO regulation.

The trollies of vehicles should be portioned in 60:40 ratio (60percent for Dry waste and 40% for wet waste.

Before providing service the vehicles should be proper branded, GPS enabled and sound system with pen drive.

Brand new vehicle / vehicle shall not be more than 1 year old to be provided by the bidder after getting the work order within 15 days
